in Arts & Commerce streams w.e.f. academic session
1989-90 (without aid).

Sir,

With reference to your application on the subject cited above, I am directed to convey the approval of the Director of Education, Delhi for the upgradation of the existing Secondary school to Senior Secondary** boxed with effect from 1989-90 session subject to the fulfilment of the following terms and conditions:-

1. That the school shall abide by the provisions of Delhi School Education Act & Rules-1973 and rules framed thereunder as well as the instructions issued from time to time.
2. That the school will meet additional liability of Senior Secondary classes.
3. That the school shall admit students without any discrimination of caste and creed.
4. That a proper library shall be established and facilities for reading room shall also be made available for students as well as teachers. Books as per the ratio of 10 books per student shall be purchased and made available to the students.
5. That adequate sports material shall be purchased and made available to the students immediately. & sports material worth Rs.5000/- may be purchased immediately.
6. That the school shall establish and equip all the science Labs. as per the norms of the department/C.B.S.E. and purchase more material immediately, worth Rs.5000/-.
7. That the school shall strictly abide by the provisions of Section 10(i) of the Delhi School Education Act and Rules, 1973 and payment shall be made through crossed cheques.
8. That the school shall not run any un-recognised classes or any other activities within the school premises and all the recognised classes shall be run at one place at the above address only. Nursery classes be removed from the premises of the school immediately.
9. That the school shall obtain the fresh Health certificate from the M.C.D. within a month & produce to E.O. for verification.
10. That that management of the school shall create a Reserve Fund of Rs.10,000/- (Rupees Ten thousand) only in the name of the Director of Education and the Manager of the school.
11. That the school society shall obtain additional land from D.D.A. and will construct the building as per the specifications of the department within a period of two years.
- 11A. That the school shall appoint full time qualified & eligible staff for all the classes of the school as per the present norms of the department.

12. Managing Committee of the school shall not increase fee in future academic session without prior approval of the Director of Education which is a mandatory requirement under sub-section(3) of section-17 of D.S.E.A.-1973.
13. That all the facilities prescribed under Rules-50 and 51 of the D.S.E.R., 1973 shall be made available to students.
14. That the school shall dispense with the services of unqualified and overaged staff, if any, immediately.
15. That the service contract between the management and the employees shall be executed immediately.
16. That the arrangements for good drinking water shall be made available to all the students as well as to the teachers and sanitary facilities shall also be provided to the students adequately.
17. The enrolment of each section shall not exceed the number of students calculated @ 12 sq.ft. per students for the available floor area of the class rooms and the school shall provide adequate and sufficient accommodation as per the norms of the Directorate of Education in each class. Number of sections should not exceed the number of existing class rooms of proper size in the school and each class room, Science Lab. and Library rooms may be fitted with proper electrical appliances.
18. That the Provident fund, family pension and group insurance benefits of the employees payable to the employees of a recognised private school, shall be made available to the employees of the school, these benefits shall not be less than those of the employees of the corresponding status in schools run by the appropriate authority.
19. That the violation of any instructions/conditions/rules and regulation of the department shall lead to the withdrawal of recognition of the school.
20. That the school shall fulfilled all the conditions as imposed above and NOC for affiliation shall only be granted after verifying the facts by the Education officer.
